The purpose of the Doncaster Community Infant Feeding Policy is three-fold: To ensure that the health benefits of breastfeeding is actively promoted to enable safe and effective breastfeeding to take place, to feed responsively to enable relationships to build regardless of method of feeding, and the potential health risks of formula feeding are understood but support is offered to feed safely if needed, are discussed with all pregnant women so that they can make an informed decision about how they will feed their baby.

□ To enable community health care staff to create an environment where more women can choose to breastfeed their babies, confident in the knowledge that they will be given support and information to enable them to breastfeed exclusively for six months, and then as part of their infants' diet to the end of the first year and beyond;

□ □ To encourage liaison between all health care professionals to ensure a seamless delivery of care, together with the development of a breastfeeding culture throughout the local community in Line with Baby friendly Initiative (BFI) standards.

It is also important that staff implement the Doncaster Community Infant feeding Policy in a non-judgemental way, so as to offer information, not advice, in order to facilitate informed choice, whilst at the same time fully supporting the woman in her choice of infant feeding. • Finally, it is essential for staff to acknowledge that the antenatal and postnatal period, and the choices made there-in, can be challenging for women, parents and families, and therefore sensitivity is needed in order not to pressure, coerce or judge the woman and the choices they make. However, women should not be prevented from being given the required information.
